4.0 Common Board of Studies:

There should be a Common Board of Studies at University level to prepare the curriculum structure and syllabi for the courses offered under University Core and University Electives.

- Board shall comprise of
- 1. Registrar Chair Person
- 2. Deans of the Schools
- 3. Subject Experts from the University faculty,
- 4. Two students from the final year.
